11/16/00 - Ran 6 joints of 7" (20#, J-55) casing, set shoe at 270'. Cement with 75 sk Type III @ 14.5 ppg. Displaced with 9 bbls freshwater, returned 6 bbls to surface. Bumped plug at 4:07 am with 127# psi. Floats held.

11/21/00 - Ran 82 joints of 4-1/2' (10.5#, J-55) casing, set shoe at 3425'. Cement with 264 sk 65:35 Poz Type III with 6% Gel, 10 pps CSE, 2% CD-32, 0.25 pps CF and 0.65% FL-32. Displaced with 55 bbls 2% KCl, returned 12 bbls to surface. Bumped plug with 900# psi at 9:00 pm. Floats held.
