12/22/00 Ran six joints of 7" (20#, J-55) casing, set shoe at 255'. Hole size is 8-3/4". Cement with 75 sk Type III with 2% CaCl and 0.25 pps Cello Flake. Displaced with 9.2 bbls freshwater, returned 5 bbls to surface. Bumped plug at 1:30 pm with 250# psi. Floats held.

12/28/00 Ran 75 joints of 4-1/2" (10.5# / J-55) casing, set shoe at 3147'. Hole size is 6-1/4". Cement with 240 sk 65:35 Poz Type III with 6% gel, 10 pps CSE, 2% CD-32, 0.65% FL-32, and 0.25 pps CF. Displaced with 49 bbls 2% KCl, returned 1 bbl to surface. Bumped plug at 12:15 pm with 1,170# psi. Floats held.
