Frac with 65,263 gals. 60Q foamed slickwater and 56,000# 20/40 sand. Clean out with mill to CIBP @ 5930'. Continue to clean out to 6500'. Circulate hole for 4 hrs. TOH with mill. TIH with 2-3/8" tubing, land @ 6145'. ND BOP & wellhead. RDMO.
