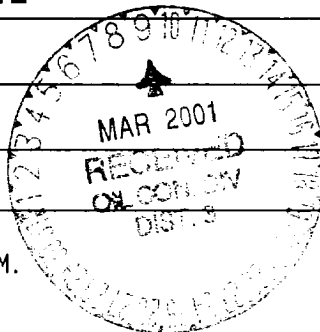

Cemented with 500 sx Class B, 65/35 Poz. 6% gel, 10#/sx gilsonite, 1/4#/sx flocele, followed with 100 sx Class B, 10#/sx gilsonite, 2% CaCl2, 1/4#/sx flocele (1112 cu.ft.). Plug down @ 11:20 am 01/27/01. Did not circulate cement. Ran temperature survey, TOC @ 1700'. WOC. Test casing to 1200 psi - OK.
