It is intended to ~~plug back~~ this wellbore to the MV as follows:

1. MIRU. TOH with tubing
2. Set CIBP above Gallup perfs at 7350'. Test casing to 3000 psi
3. Perform any remedial cement work as needed.
4. Selectively perforate the Mesa Verde from 5561-6082 and fracture treat interval.
5. TIH and clean out with air mist.
6. Land tubing at 6050'. Return to production.

Note: It is intended to downhole commingle the Gallup and MV at a later date.
