Cement with 150 sks Class B, 2% CaCl<sub>2</sub>, 1/4#/sk flocele (177 cu. ft.). Plug down @ 5:50 am 11/10/01. Circulate 50 sks cement to surface. RD Halliburton. WOC. NU BOP. Test BOP and casing to 600 psi - OK.
