Cmtd first stage w/182 sx Class "H" Type III cmt w/1% calcium chloride, 0.25 pps Cellophane, 0.2% reducer (251 cu.ft.). Displace w/40 bbl wtr, 96 bbl mud. Circ 12 bbl cmt to surface. Stage tool set @ 2680'. Pump 20 bbl wtr, 20 bbl chemical wash, 20 bbl wtr ahead. Cmtd second stage w/425 sx Class "H" premium lite cmt w/8% gel, 3% calcium chloride, 0.25 pps Cellophane, 5 pps Gilsonite, 0.04% fluid loss, 0.4% sodium metasilicate (905 cu.ft.). Displace w/108.5 bbl wtr. Circ 28 bbl cmt to surface.

8-4-01 PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.

8-6-01 Drill to TD @ 7658'. Circ hole clean.

8-7-01 TOOH. TIH w/179 jts 4 1/2" 10.5# K-55 csg, set @ 7658'. Pump 10 bbl chemical wash, 2 bbl wtr ahead. Cmtd w/309 sx Class "B" 65/35 poz w/6% gel, 0.25 pps Celloflake, 3% calcium chloride, 6.25 pps Gilsonite, 1% fluid loss, 7 pps CSE (624 cu.ft.). Displace w/122.5 bbl wtr. PT csg to 3800 psi/15 min, OK. ND BOP. NU WH. RD. Rig released.
