It is intended to alter the approved surface casing depth and cement of the subject well. A 9 7/8" hole will be drilled to 120'. 7" 20# J-55 casing will be run to 120'. It will be cemented with 27 sacks Class A, B Portland Type I, II cement (32 cu.ft. of slurry, bringing cement to surface through 6 1/2" line).
