Lost returns 138 bbl into displacement. Circ 5 bbl cmt to surface.

6-21-01 Stage tool set @ 2859'. Pump 20 bbl wtr, 20 bbl chemical wash, 20 bbl wtr ahead. Cmdt second stage w/425 sx TXI lightweight cmt w/2.5% gel, 2% calcium chloride, 0.5 pps Cellophane, 10 pps Gilsonite, 0.2% antifoam (1097 cu.ft.). Displaced w/115.8 bbl wtr. Circ 100 bbl cmt to surface. WOC.

6-24-01 Drill to TD @ 7829'. Circ hole clean. TOO. TIH w/183 jts 4 1/2" 10.5# J-55 ST&C csg, set @ 7821'.

6-25-01 Establish circ. Circ hole clean. Pump 10 bbl chemical wash, 2 bbl wtr ahead. Cmdt w/434 sx Class "B" 50/50 poz w/5% gel, 0.25 pps Cellophane, 5 pps Gilsonite, 0.25% fluid loss, 0.15% dispersant, 0.1% antifoam, 0.1% retardant (625 cu.ft.). Displace w/127 bbl wtr. WOC. ND BOP. NU WH. RD. Rig released.
