Pump 20 bbl wtr, 20 bbl mud flush, 20 bbl wtr ahead. Cmdt second stage w/478 sx Premium Lite cmt w/3% calcium chloride, 0.25 pps Celloflake, 5 pps LCM-1, 0.4% fluid loss, 0.4% sodium metasilicate (1018 cu.ft.). Displace w/135 bbl wtr.
