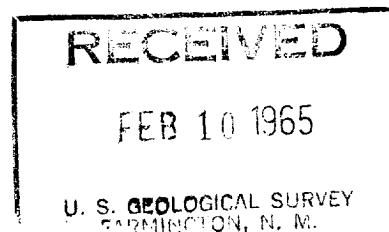

Total depth 6255'. Plugged back depth 6225'.

Ran tubing with packer and set packer at 5870'. Perforated casing through tubing from 6184' to 6190' with 20 jet shots. Pumped 200 gallons mud acid in perforations. Formation broke at 1900 psi. Average injection rate one barrel per minute at 1400 psi, five minute shut in pressure 1300 psi. After swabbing, well kicked off and commenced flowing.
