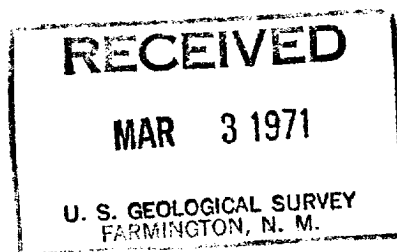

2-22-71 through 2-28-71:

Ran casing inspection log. Set Baker Model "D" packer with expendable plug at 5900'. Located hole in casing between 3820 - 3854'. Squeezed zone with 100 sacks Class "C" cement with 6% Halod No. 9 and 50 sacks Class "C" cement with .6 Halod 9 and 2% Calcium Chloride. Flushed hole with 5 barrels water. Squeezed same zone with 75 sacks Class "C" cement with 2% Calcium Chloride. Drilled out cement and tested casing to 1250#. Held okay. Circulated casing-tubing annulus with water containing Bariod Coat "C" 1815 inhibitor and pushed out plug in Model "D" packer. Blew well to clean up and placed on production.

Instructions
