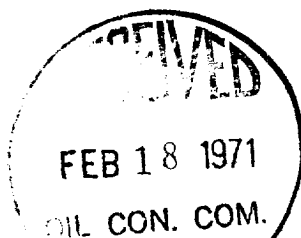
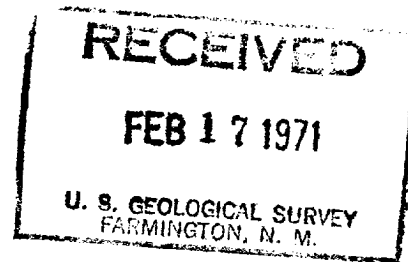

1. RIG UP PULLING UNIT. PULL 1 1/2" E.U.E. TUBING.
2. RUN 4 1/2" BAKER MODEL "G" PACKER ON 1 1/2" E.U.E., 2.90#, JCN TUBING. SET PACKER AT APPROXIMATELY 6300 FT. R.K.B. BOTTOM OF TUBING WILL BE SET APPROXIMATELY 6620 FT. R.K.B.
3. FILL ANNULUS BETWEEN 1 1/2" TUBING AND 4 1/2" CASING FROM TOP OF PACKER TO SURFACE WITH APPROXIMATELY 80 BBL. INCO KEN-PACK MATERIAL.
4. COMPLETE REPAIR AND RETURN WELL TO PRODUCTION.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
