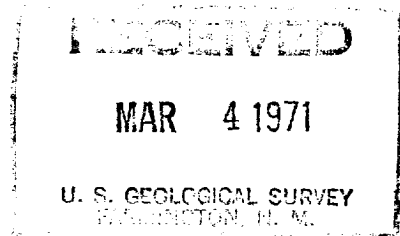
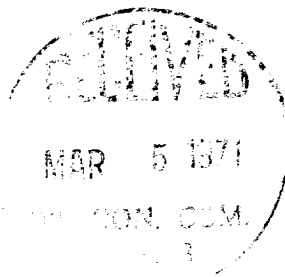

1. Moved in and rigged up Pulling Unit February 22, 1971. Circulated hole clean and pulled 1-1/2", E.U.E., tubing.
2. Ran 4-1/2" Model "G" Baker packer and 203 jts. of 1-1/2", E.U.E., 2.90#, JCW tubing. Set packer at 6163 ft. R.K.B. with bottom of tubing at 6620 ft. R.K.B. Filled Annulus between 1-1/2" tubing and 4-1/2" Csg. from top of packer to surface with 75 Bbl. IMCO Ken-Pack material.
3. Nipped up Wellhead and swab well in.
4. Repair completed February 25, 1971.
