THE APPLICATION OF EL PASO NATURAL GAS PRODUCTS COMPANY FOR PERMISSION TO EFFECT DUAL COMPLETION OF ITS DELHI-TAYLOR WELL NO. 1-C (GD) LOCATED 790 FEET FROM THE SOUTH LINE AND 790 FEET FROM THE WEST LINE OF SECTION 4, TOWNSHIP 26 NORTH, RANGE 11 WEST, NMPM, SAN JUAN COUNTY, NEW MEXICO, IN SUCH A MANNER AS TO PERMIT THE PRODUCTION OF GAS FROM AN UNDESIGNATED DAKOTA FORMATION AND THE PRODUCTION OF OIL FROM THE GALLUP-FORMATION ADJACENT TO THE GALLEGOS-GALLUP POOL.



ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 112-A (c) El Paso Natural Gas Products Co. made application to the New Mexico Oil Conservation Commission on January 21, 1959, for permission to dually complete its Delhi-Taylor Well No. 1-C (GD) located 790 feet from the South line and 790 feet from the West line of Section 4, Township 26 North, Range Il West, NMPM, San Juan County, New Mexico, in such a manner as to permit the production of gas from an undesignated Dakota formation and the production of oil from the Gallup formation adjacent to the Gallegos-Gallup Pool.

Now on this 10th day of February, 1959, the Secretary-Director finds:

- (1) That application has been duly filed under the provisions of Subsection 'c' of Rule 112-A of the Commission's Rules and Regulations;
- (2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the proposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and consonant with good conservation practices.

IT IS THEREFORE ORDERED:

That the applicant herein, El Paso Natural Gas Products.Co., be and the same is hereby authorized to dually complete its Delhi-Taylor Well No. 1-C (GD) located 790 feet from the South line and 790 feet from the West line of Section 4, Township 26 North, Range Il West, NMPM, San Juan County, New Mexico, in such a manner as to permit the production of gas from an undesignated Dakota formation and the production of oil from the Gallup formation adjacent to the Gallegos-Gallup Pool through parallel strings of tubing.

PROVIDED HOWEVER, that applicant shall complete, operate, and produce said well in accordance with the provisions of Section V, Rule 112-A, as amended by Order R-1214.

PROVIDED FURTHER, that applicant shall take packer-leakage tests upon completion and annually thereafter during the Annual Gas-Oil Ratio Test Period for the Gallegos-Gallup Pool.
