March 30, 1968, moved in and rigged up pulling unit. Pulled rods and tubing. Squeezed casing perforations 5066-5135' with 15 sacks of cement, 3% gel. Top of plug at 4985'. Worked 5-1/2" casing with 160,000# tension. Found free point at 2150'. Shot 5-1/2" casing at 2146'. Spotted 20 sacks cement 2096'-2196'. Pulled 67 joints (2141') of 5-1/2" OD 14# J-55 "C" condition casing. Set 10 sacks cement in top of surface casing with dry hole marker.
