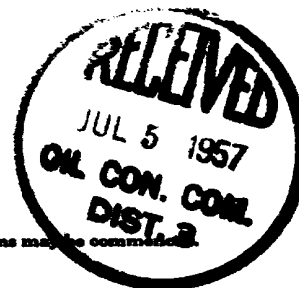

DETAILS OF WORK

It is proposed to drill with rotary tools to a depth of 150+ feet, set 9-5/8" casing and cement to surface with 100 sand, plus up-sink. It is then proposed to drill through the Pictured Cliff Formation, ~~re-sink~~ log and run 7" production casing. It is then proposed to run production 7" casing opposite the Pictured Cliff Formation and to stimulate the producing zone with a sandwater free. The proposed drilling unit is the NE 1/4 of Section 9 (150 acres)

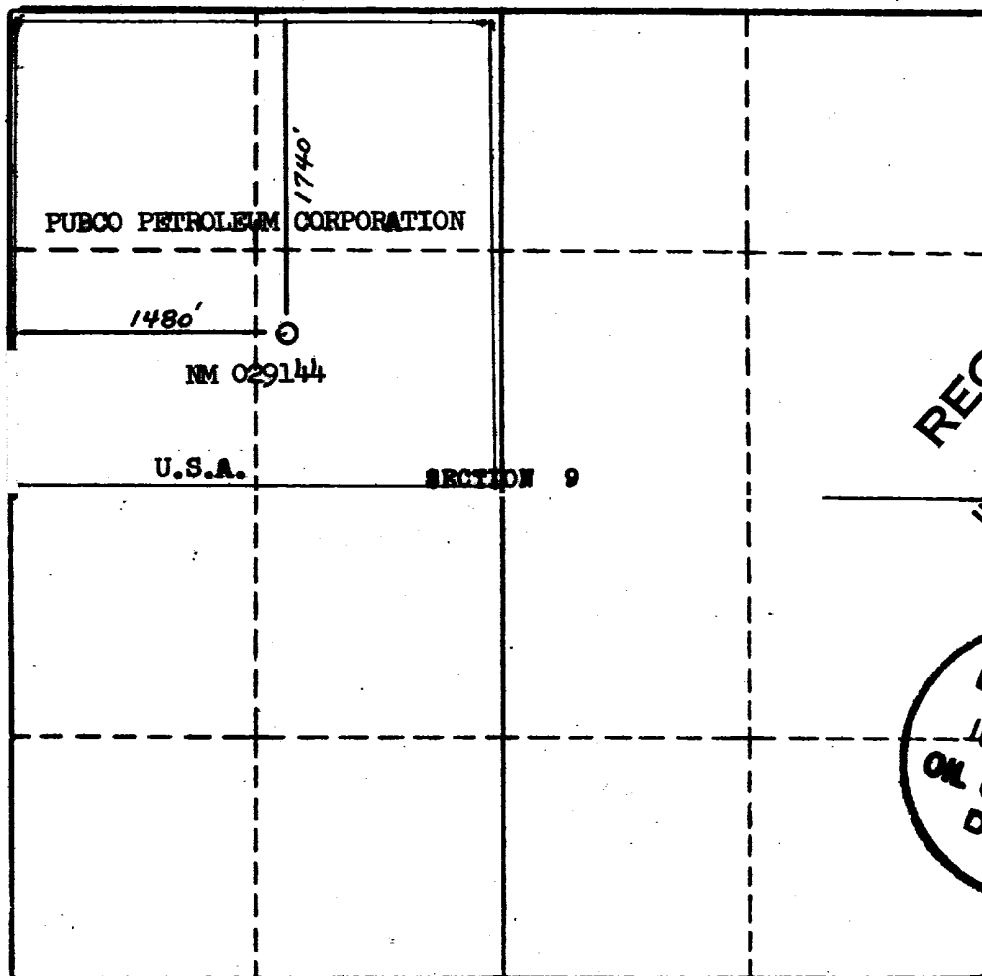
