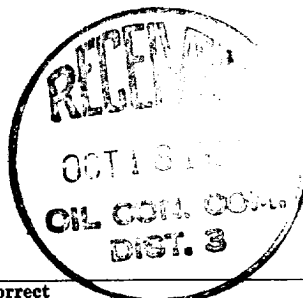

1. Spudded 12-1/4" surface hole 9/20/67. Drilled to total depth of 338 ft. R.K.B.
2. Ran 10 fts. of 8-5/8", 24.0#, J-55 casing. Landed at 335 ft. R.K.B. Cemented with 250 sacks of regular cement. Plug down at 2:30 P.M. 9/20/67.
3. Nippled up and pressure tested casing to 800 p.s.i. for 15 minutes. Test OK.
4. Drilled out from under surface casing with 7-7/8" hole on 9/21/67.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

In addition, such proposals and reports should include reasons for the abandonment; data on any former or present productive zones, or other zones with present significant fluid contents not sealed off by cement or otherwise; depths (top and bottom) and method of placement of cement plugs; mud or other material placed below, between and above plugs; amount, size, method of packing or any casing, liner or tubing pulled and the depth to top of any left in the hole; method of closing top of well; and date well site conditioned for final inspection looking to approval of the abandonment.
