3-20-68 T. D. 6743', ran 210 joints 4 1/2", 10.5#, J-55 casing (6733') set at 6743'. Float collar set at 6730', second stage at 4825', third stage at 2318'. Cemented first stage w/250 sacks of cement, second stage w/200 sacks of cement, third stage w/175 sacks of cement. W.O.C. 18 hours.

3-21-68 F.B.T.D. 6730'. Tested casing to 4000# O. K. Spotted 300 gal. 7 1/2% acid. Perf. 6572-82, 6598-6603', 6660-75', 6690-95', 6720-25' w/20 SPZ. Free w/60,000# 20/40 sand, 60,690 gal. water. Max. pr. 4000#, KDP 3400#, tr. pr. 3100-3500-4000#. I.R. 35 BPM. Dropped 4 sets of 20 balls each. Flushed w/5040 gal. water. IBIP 1200#, 5 Min. 900#, 30 Min. 600#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
