We attempted to restore the subject well to production by unloading it with a compressor. Unfortunately, this attempt was unsuccessful. We will now evaluate for a refracture stimulation. Since we do not own the coal rights, we will have to contact the Fruitland formation owner and the New Mexico Oil Conservation Division to determine a procedure to fracture stimulate without communication with the Fruitland formation.
