SURFACE USE OPERATIONS PLAN

MERRION & BAYLESS Blackrock D-1E Section 20, T26N, R11W San Juan County, New Mexico

- 1 & 2. A topographical map is attached showing location of drillsite and access roads to location; new roads are color coded on the location map. The terrain is relatively flat and no improvements are planned on existing roads. Our planned access road will be twelve feet in width, and will follow the existing terrain. No turnouts, culverts or cuts and fills are anticipated on the proposed access. In addition, natural drainage and surfacing material will be used.
