5/15/02 Established injection with 8 bbls of water. Filled 2-7/8" casing with 40 sx (47 cu.ft.) of CI "B" cem with celloflake. Pressured to 600 psi but leaked off. Pumped another 5 sx (6 cu.ft.) of cement to 800 psi. Pressure leaked off and cement continued to fall. WOC 2.5 hrs. Filled 2-7/8" with 8 sx (9 cu.ft) of CI "B" cement with celloflake. Pressured to 1000 psi and held. BLM witnessed the job. Installed dry hole marker and cleaned up the location.
