

1. Run GR-CCL-CNL
2. Perforate WAW Fruitland Sand/Pictured Cliffs 1182'-88' with 4 spf (total 24 holes).
3. Acidize with 1,500 gals 15% HCL.
4. Frac interval 1182'-88' with 41,300 gallons 70 quality foam in 20 lb crosslink gel carrying 50,000 lb 16/30 sand.
