3. Spot a 240 foot cement plug from 5812-5572 to cover perf. int. 5762-5622'.
4. Spot a 306 foot cement plug from 3514-3508 to cover perf. int. 3864-3658'.
5. Determine 5 1/2" casing free point and cut casing.
6. Spot a 100 foot cement plug across cut-off, pull casing.
