## Gentlemen:

On January 31, 1963 we received in this office a tabulation of deviation tests run on the Foutz-Burson #1 Val well located in Unit I-27-28N-1W, Rio Arriba County.

We have calculated the maximum deviation from this survey and find it to be 585.3 feet. As this well is located 2310 feet from the South line and 990 feet from the East line of Section 27 it is only 330 feet from a quarter-quarter section line on the West and the half-section line to the North. It is, therefore, possible that the bottom of the hole is not located on the 40-acre tract upon which the surface location was drilled.

Under our rules it will be necessary that we require a directional survey to be run on this well in order to establish the location of the bottom of the hole.
