Spud at 12 noon 8/19/62. Drilled 13-3/4" hole to 130'. Ran 5 joints of 9-5/8" - 36' - 115' including Baker shoe. Cemented at 128' with 150 max class A cement with 2% CaCl₂. Circulate returns to surface and W.O.C. 2 1/2 hrs. Pressure tested with 600 psi for 30 minutes, held O.K. Drilling ahead.
