Run 90 jts. 9 5/8", J-55, 36.00 # casing (3581) set at 3592 with 150 sks. reg. cement, containing 2 # Calcium Chloride 2 # 1/2 cu.ft. Strata-Crete "5" per sack. Held 1500 # 30 minutes.

Run 73 jts. 7", 23 #, H-80, Casing (2508)' & 174 jts. 7", 23 #, J-55, casing (5333'), for a total of 252 jts. (7841') set at 7852 w/535 sks. Pozmix, 535 sks. reg. cement with 1 # Floccula/sk & 4 # Del, 1 # Fine Thuffplug/sk. 0.4 # H-4 & 50 sks. reg. with 0.6 # H-4. Held 1000 # 30 min. Top of cement by temp. survey 3360'.
