

It is intended to commingle the existing Mesaverde/Dakota dual by removing the dual tubing configuration. We will also add the Lewis and Menefee intervals to the existing Mesaverde interval, by isolating existing perforations with cast iron bridge plugs and stimulating. The well will then be cleaned up, commingled and returned to production with a single string of tubing. DHC-2050 has been obtained from the Oil Conservation Division.
