2. Plug #1 4197' to 3200'. Cement w/ 283 sxs. 273 sxs below cr & 10 sxs above
3. Plug #2 2579' to 2679'. Cement w/29 sxs across Mesa Verde top
4. Perforate @ 538'
5. Plug #3 538' to surface. Cement w/235 sxs cement.
6. Place dry hole marker in well, weld marker to casing below ground level.
7. Remove surface equipment, recontour and reseed location.
