DETAILS OF WORK

It is intended to drill & dual complete a well in the Dakota formation & Mesa Verde formation. Mud circulation will be used thru the Pictured Cliffs and set intermediate casing. Gas circulation will be used thru the middle of the Greenhorn formation & 7" liner will be set. Mud circulation will be used thru the Dakota formation & production liner will be set. Possible productive intervals will be perforated and fractured. Est. T. D. 8695'.

Casing Program:

- 13 3/8" at 300' w/450 sks. cement circulated to surface.
- 9 5/8" at 4484' w/860 sks. cement in two stages.
- 7" at 8250' w/600 sks. cement.
- 5" at 8695' w/200 sks. cement.

The S/2 of Section 26 is dedicated to the Mesa Verde formation.
The S/2 of Section 26 is dedicated to the Dakota formation.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

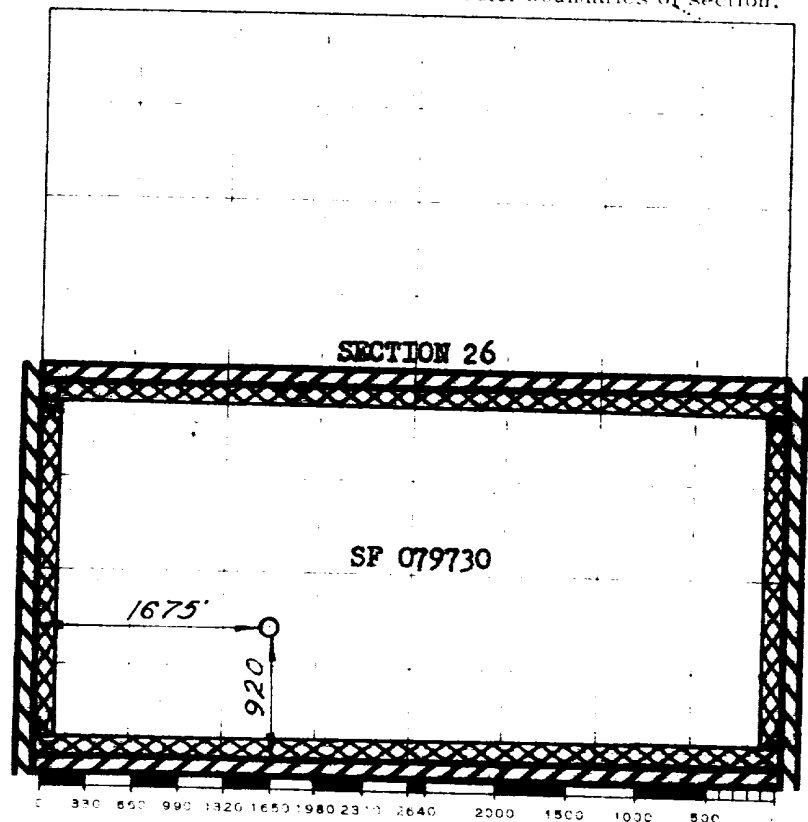
