DETAILS OF WORK

It is intended to drill a well with rotary tools through the Monkheads, drilling the pay with gas circulation, and to shoot the entire Monkheads with 2 quarts of S.S.G. per foot. Total depth 6200'.

Casing program:

9-5/8" at 160' with 125 sacks of regular cement circulated to surface.
7" at 5400' with 300 sacks of regular cement.

The 1/2 of Section 26 is dedicated to this well.
