### DETAILS OF WORK

It is intended to drill a well with rotary tools thru the Mesa Verde formation. Mud circulation will be used thru the Pictured Cliffs and set intermediate casing. #### Casing Program:

10 3/4" at 170' with 125 sacks cement circulated to the surface.  
7 5/8" at 2909' with 250 sacks cement.  
5 1/2" at 5109' with 150 sacks cement.

The 1/2 of Section 29 is dedicated to this well.
