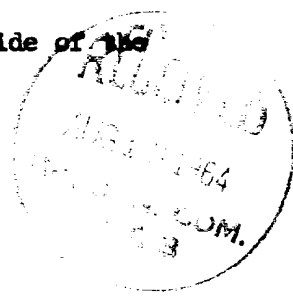
Due to a suspected casing leak and a non-commercial Pictured Cliffs zone it is intended to re-work this well in the following manner:

Pull tubing and drill up the packer.

Run magnetic casing inspection log in the 7 5/8" casing.

Squeeze-off the Pictured Cliffs zone with cement.

Repair any casing leak in the 7 5/8" casing by running 5 1/2" casing inside of the 7 5/8" casing from the wellhead to the present 5 1/2" liner and cement.
