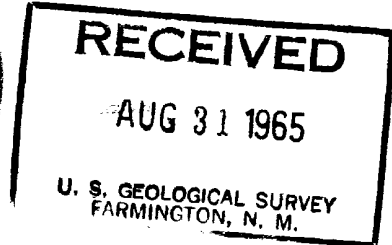

Instructions

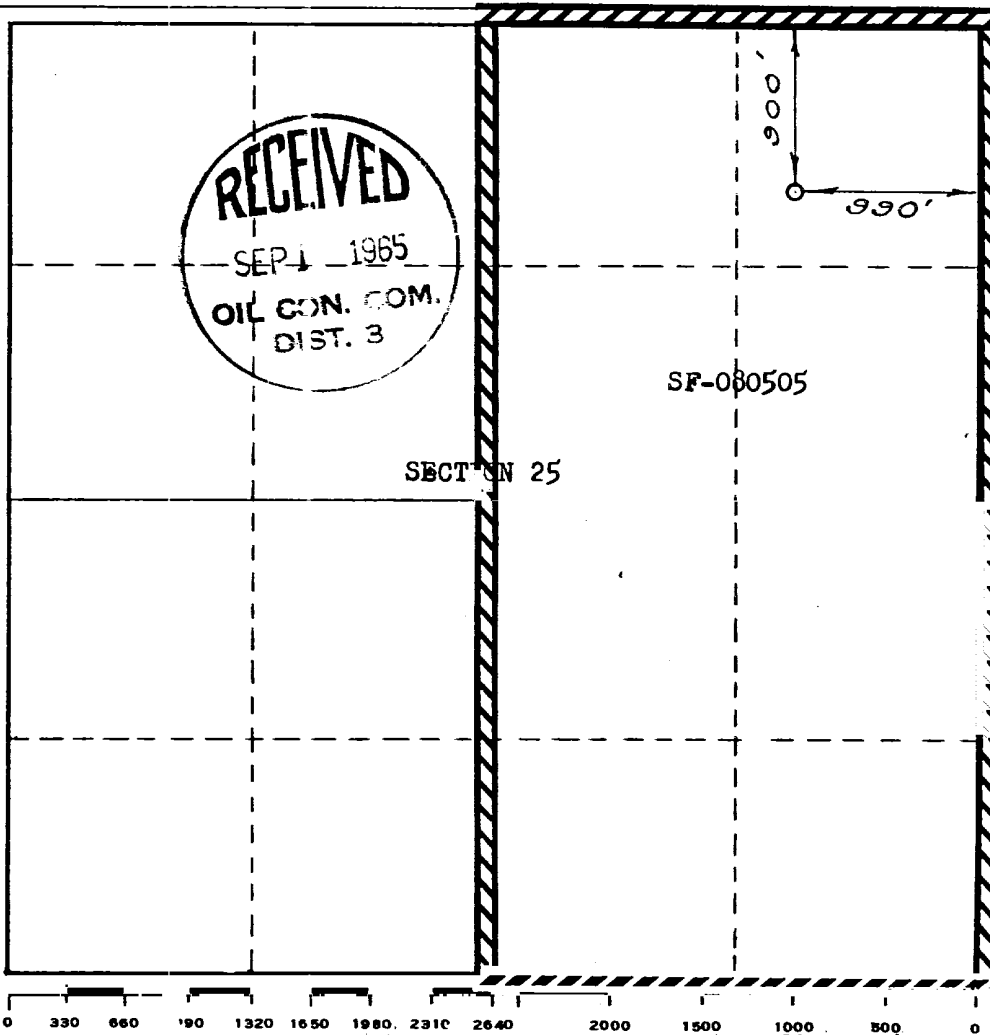
