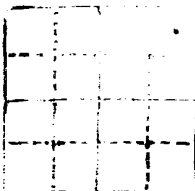

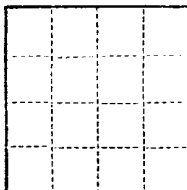

DETAILS OF WORK

7 at 5000' with 250 sacks Pozmix and 250 sacks regular cement.
