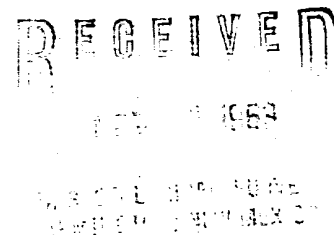

- 1. Pull tubing and set a top drillable magnesium bridge plug below the second stage collar.**
- 2. Pressure test both stage collars w/a packer and squeeze the leak.**
- 3. Drill out cement and test squeeze job.**
- 4. Drill bridge plug and re-run tubing.**

Instructions
