On 5-1-64 set packer at 2431', held O. K., set packer at 2455', pumped in 3 bbl/min at 1000#, hole at 2450' & 2466'. Set packer at 2750', held O. K., set packer at 2732' held O. K., 2720' O. K., 2660', O. K. Set full bore packer at 2250'. Squeezed holes at 2450' and 2466' w/200 sacks regular cement, 2% calcium chloride, staged squeeze to 2000#, reversed out.
