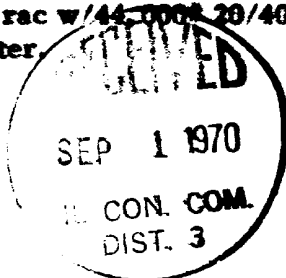
On 7-31-70 pulled tubing.

On 8-1-70 shot off 5 1/2" uncemented liner at 4980', pulled 111' of liner. Set cement retainer at 4880', squeezed open hole w/150 sacks of cement. Perf. one squeeze hole at 2690', set cement retainer at 2645', squeezed thru perf w/125 sacks of cement.

On 8-3-70 set cement retainer at 4829', re-squeezed open hole w/150 sacks of cement.

On 8-7-70 T.D. 5773', ran 177 joints 4 1/2", 10.5#, KS production casing (5764') set at 5773' w/125 sacks of cement. W. O. C. 18 hours.

On 8-9-70 P.B.T.D. 5762', perf. 5512-18', 5530-42', 5590-5602', 5622-34', 5670-76' w/18 SPZ. Frac w/60,000# 20/40 sand, 49,308 gal. water, dropped 4 sets of 18 balls, flushed w/4452 gal. water. Pumped bridging ball to baffle at 5332', tested to 3500# O. K. Perf. 5006-18', 5104-10', 5120-20', 5141-51', 5161-71' w/18 SPZ. Frac w/44,000# 20/40 sand, 43,832 gal. water, dropped 4 sets of 18 balls, flushed w/3486 gal. water.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
