In order to increase production it is planned to workover and restimulate this well in the following manner:

Pull tubing, set a drillable bridge plug near the base of 5 1/2" liner and test casing and liner to 3500 psi. Repair leaks (none are expected).

Flow casing dry, drill bridge plug and clean out to total depth w/gas circulation.

Sand water fracture the open hole, set a drillable bridge plug and perforate and sand water fracture the upper Point Lookout and Cliff House pay zones.

Clean out and re-run tubing.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
