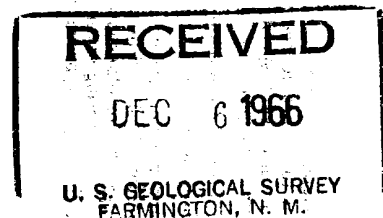

12-3-66 T.D. 7852'. Ran 34 joints 11.6 & 221 joints XX 10.5#, 4 1/2", J-53 casing, total of 245 joints (7839') set at 7852'. Float collar at 7820', stage tools at 5781' and 3605'. Cemented first stage w/280 sks. cement, 2nd stage w/190 sks. cement, 3rd stage w/175 sks cement. W.O.C. 18 hours. Tested w/1500#/30 min. O. K.

12-5-66 Tested casing w/4000#, spotted 500 gal. 7 1/2" MCA, perf. Dakota 7611-27, 7712-28, 7777-93, 7814-22 w/16 SPZ, frac w/50,000# 40/60 sand, 63,630 gal. water. Max. pr. 4000#, BDP 1500#, tr. pr. 3500-3900-4000#. I.R. 38 BPM. Dropped 3 sets of 16 balls each, flushed w/5490 gallons of water. ISIP 1900#, 5 Min. 1700#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
