On 8-20-67 spudded well, drilled surface hole and ran 10 joints 9 5/8", 32.30#, H-40 casing (320') set at 331' w/270 sacks of cement circulated to surface. W.O.C. 12 hours, tested w/600#/30 Min. O. K.

On 9-12-67 T. D. 7931', ran 248 joints 4 1/2", 11.6 & 10.5# J-55 casing (7921') set at 7931'. Float collar at 7922', second stage tool at 5869', third stage tool at 3675'. Cemented first stage w/300 sacks cement, second stage w/215 sacks, third stage w/180 sacks. W.O.C. 18 hours.

On 9-13-67 P.B.T.D. 7922', tested casing w/4000# O. K. Spotted 300 gal. 7 1/2" ECL. Perf. Dakota 7682-98', 7732-36', 7788-96', 7830-34', 7845-53', 7864-72', 7884-92' w/16 SPZ. Frac w/80,000# 40/60 sand, 80,000 gal. water. Max. pr. 4000#, BHP 1700#, tr. pr. 3600-3800-4000#. I.R. 40 HPM. Dropped 6 sets of 16 balls each, flushed w/5250 gal. water. ISIP 2200#, 5 Min. 2000#, 15 Min. 1950#, 30 Min. 1900#.
