On 9-6-67 ran 10 joints 9 5/8", 32.30#, H-40 casing (315') set at 330' w/270 sacks of cement circulated to surface. W.O.C. 12 hours, tested w/600#/30 Min. O. K.

On 9-29-67 T. D. 7684', ran 241 joints 4 1/2", 11.6 & 10.5# J-55 casing (7673') set at 7684'. Float collar at 7673', second stage tool at 5595', third stage tool at 3342'. Cemented first stage w/300 sacks of cement, second stage w/200 sacks, third stage w/200 sacks. W.O.C. 18 hours.

On 9-30-67 P.B.T.D. 7673', tested casing to 4000# O. K. Spotted 300 gal. 7 1/2% regular acid. Perf. 7446-58', 7545-57', 7590-96', 7610-22', 7638-56' w/24 SPT. Free w/60,000# 40/60 sand, 66,110 gal. water. Max. pr. 4000#, BEP 1300#, tr. pr. 3500-3800-4000#. I.R. 38 BPM. Dropped 4 sets of 24 balls each, flushed w/5400 gal. water. ISIP 1800#, 5 Min. 1500, 15 Min. 1400#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
