Instructions

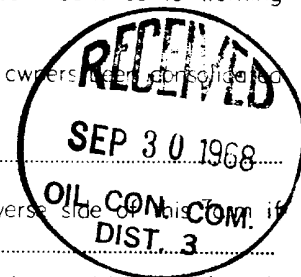

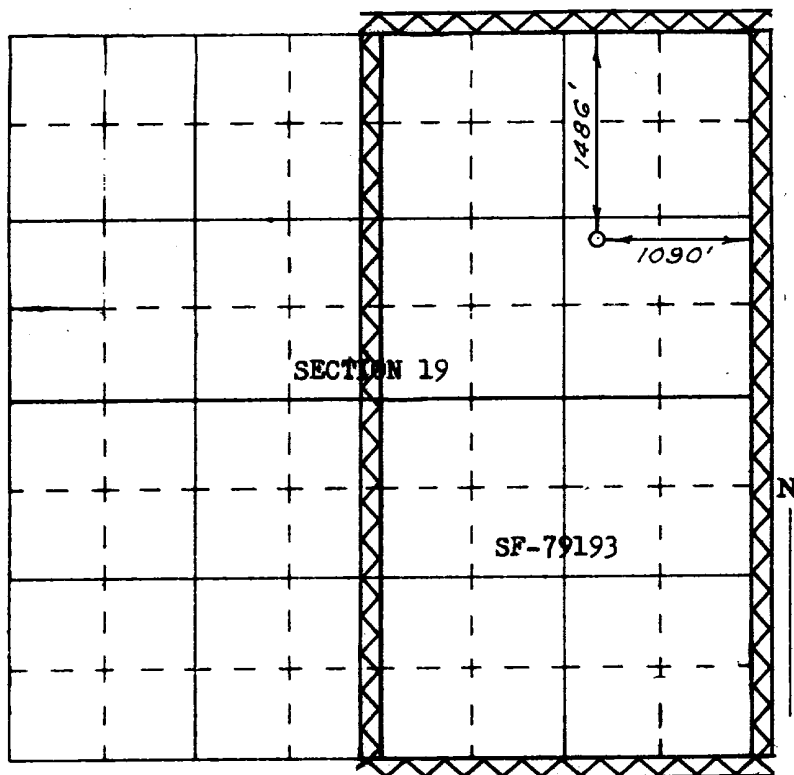
