On 4-12-70 T. D. 3458'. Ran 106 joints 7", 20", KS intermediate casing (3442') set at 3458' w/173 sacks of cement. W.O.C. 14 hours, held 800#/30 min.

On 4-18-70 T. D. 7755'. Ran 238 joints 4 1/2", 10.5 & 11.6" KS production casing (7743') set at 7755' w/360 sacks of cement. W.O.C. 18 hours.

On 4-19-70 P.B.T.D. 7744'. Perf. 7479-85', 7499-7505', 7594-7608', 7632-44', 7690-7702' w/24 SPZ. Frac w/60,000 40/30 sand, 60,000 gal. water, dropped 4 sets of 24 balls, flushed w/5880 gal. water.
