It is proposed to recomplete this well to the Mesaverde by the following procedure:

1. Set CIBP at 5280' to isolate Dakota perforations.
2. Perforate Menefee from 4716' - 4809' and Point Lookout from 5069' - 5117', 18 total holes; treat with 500 gals 15% HCL and frac.
3. Set CIBP at 4650', perforate Cliffhouse from 4466' - 4598', 22 total holes; treat with 500 gals 15% HCL and frac.
4. Drill out all CIBPs, clean out well to PBTD and put on production.
