10-21-73 TD 4648'. Ran 111 joints 7", 23# and 20#, J-55 intermediate casing, 4644' set at 4648'. Cemented with 212 cu. ft. cement. WOC 12 hours, held 1200#/30 min. Top of cement at 3600'.

10-29-73 TD 8772'. Ran 271 joints 4 1/2", 11.6 and 10.5#, N-80 and K-55 production casing, 8760' set at 8772'. Float collar set at 8760'. Cemented with 678 cu. ft. cement. WOC 18 hours. Top of cement at 4195'.

11-18-73 PBTD 8760'. Tested casing to 4000#-OK. Perf'd 8561', 8565', 8636', 8638', 8682', 8688', 8707', 8711', 8722' and 8728' with one shot per zone. Frac'd with 43,000# 40/60 sand and 58,630 gallons treated water. No ball drops. Flushed with 400 gallons water.
