It is proposed to recomplete this well to the Mesaverde by the following procedure:

1. Set CIBP at 5650' to isolate Dakota perforations.
2. Perforate Point Lookout from 5422' - 5605', 21 total holes; treat with 500 gals 15% HCL and frac.
3. Set CIBP at 5050', perforate Cliffhouse/Menefee from 4875' - 5010', 17 total holes; treat with 500 gals 15% HCL and frac.
4. Drill out all CIBPs, clean out well to PBTD and put on production.

Application for Down Hole Commingling of Mesaverde and Dakota has previously been submitted.
