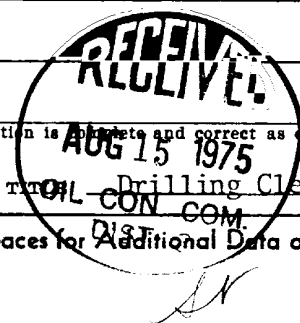

INSTRUCTIONS
