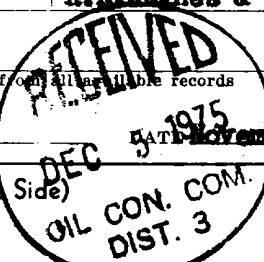

# INSTRUCTIONS
