We propose to test Pictured Cliffs and Mesaverde formations by drilling hole with mud. Will log well, set 5-1/2" casing thru the Mesaverde formation, selectively perforate, sand-water frac, clean out, and complete well.

We will dually-complete the well if Pictured Cliffs formation is productive.

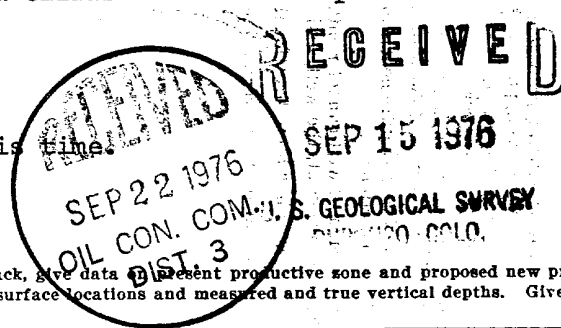

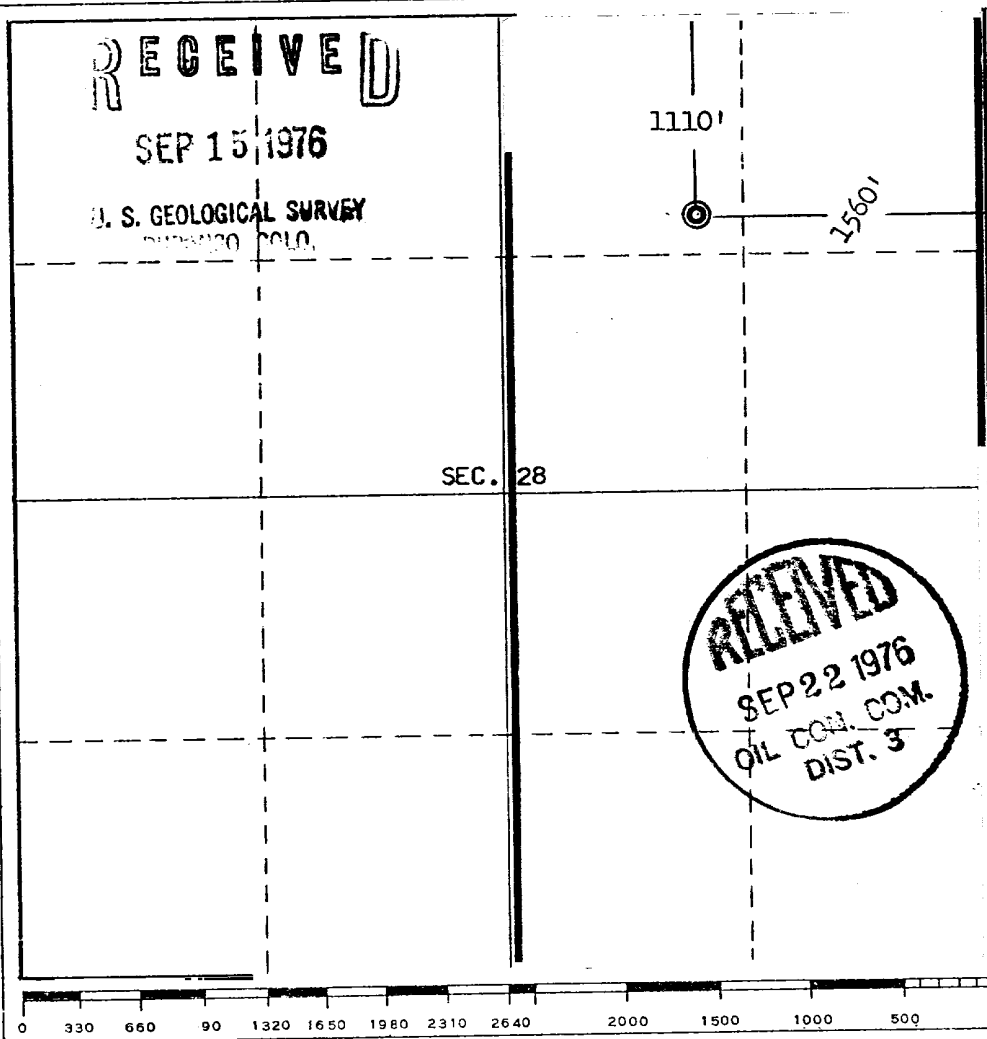
